Results of NZILA Charge-Out Rate Survey 2009

The survey was conducted over a 3-week period in May 2009 and was a voluntary, online survey that was prompted by two emails to all NZILA members. It was designed to find out the average hourly charge-out rate for landscape architects for a variety of experience levels, locations and projects.

There were a total of 146 responses.

There were some issues with the ability to answer section 2, but this appears to have affected only 5 respondents, who were unfortunately unable to complete the survey (and are not included in the total 146).

All figures are rounded to the nearest dollar value, based on 1 hour of work chargeable to a client, and do not include GST or disbursement costs.

No analysis has been undertaken on the results - they are simply presented in a tabular format. It is important to note that although the results have been broken down into small groups (eg a Fellow or Life Member providing evidence for a Community Group at the Environment Court), such level of detail is provided for interest only and is not statistically significant (in the example, \$110 is posted, but is based on only one response in that category). The following table outlines the percentage of Respondents in each category:

Examples

10% of total respondents were Fellows or Life Members.

50% of total respondents had 5-10 years experience.

6% of total respondents were Registered members with 5-10 years experience.

For each category the range (minimum and maximum values) are shown in brackets underneath the average.

Additionally, for each question a 'Normal Distribution' standard deviation has been used to eliminate outliers. The summary range results shown are 1.05 standard deviations either side of the mean average, showing the range of the middle 70% of the population.

Not all categories are displayed for each question - the number of respondents in the 'Other' category was small, and few respondents have worked for local iwi in the past 12 months. However, these responses are included in the overall averages.
